

Decree No. (26) of 2022
Transferring the
Ownership of a Land Plot to the Expo City Authority¹

We, Mohammed bin Rashid Al Maktoum, Ruler of Dubai,

After perusal of:

Law No. (24) of 2009 Establishing the Dubai Financial Support Fund and its amendments;

Law No. (14) of 2022 Establishing the Expo City Dubai; and

Decree No. (39) of 2009 Transferring the Ownership of a Land Plot to the Dubai Financial Support Fund,

Do hereby issue this Decree.

Transfer of Ownership
Article (1)

The ownership of Land Plot No. 5910130 located in Jebel Ali First Area is hereby transferred from the Dubai Financial Support Fund to the Expo City Dubai Authority.

Rights and Obligations
Article (2)

All rights and obligations of the Dubai Financial Support Fund in respect of the land plot referred to in Article (1) hereof, and any constructions thereon, are hereby transferred to the Expo City Dubai Authority.

Article (3)

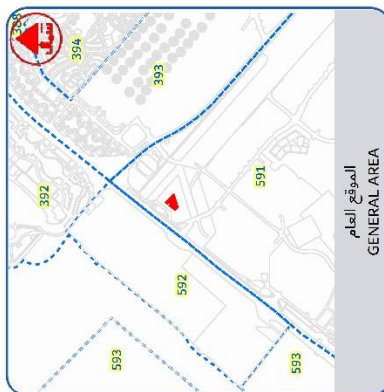
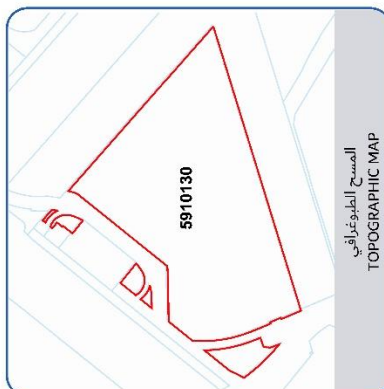
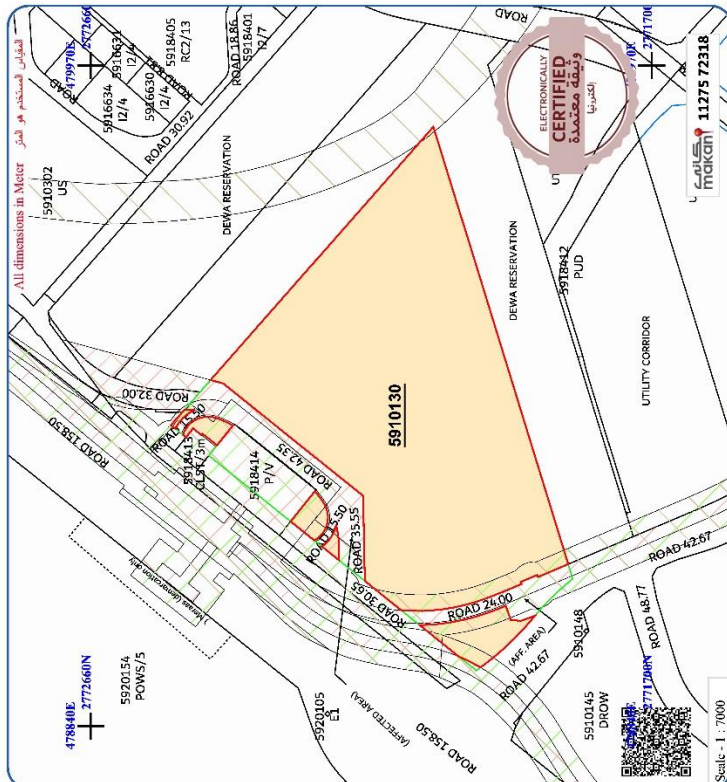
The Dubai Municipality and the Dubai Land Department must, each within its own jurisdiction, take the action required for the implementation of the provisions of this Decree.
