

Administrative Resolution No. (138) of 2025

Approving the Fees for the Reservation of Spaces at Al Safa Library¹

The Director General of the Dubai Culture and Arts Authority,

Does hereby issue this Resolution.

Approval of Fees Article (1)

- a. Pursuant to this Resolution, the fees for the reservation of spaces at Al Safa Library, as set out in the Schedule attached hereto, are approved.
- b. The value added tax prescribed by the tax legislation in force in the United Arab Emirates will be added to the fees approved under this Resolution.

Article (4)

This Resolution comes into force on the day on which it is issued, and will be published in the Official Gazette.
