2	Failure to present the Unified Card upon request	200
3	Using a card issued to another person	200
4	Using an expired card	200
5	Using an invalid card	200
6	Using a counterfeit card	500
7	Selling Unified Cards without prior permission from the RTA	200
8	Damaging, vandalising, or destroying equipment, devices, or seats on Public Transport or within Public Transport Facilities and Services	2,000
9	Spitting, littering, or performing any act that may compromise the cleanliness of Public Transport and Public Transport Facilities and Services	200
10	Causing a disturbance or inconvenience in any way to users of Public Transport or Public Transport Facilities and Services	100

20	Opening the doors of, or attempting to board or alight from, Public Transport while it is in motion between stations or stops	400
21	Accessing or sitting in areas designated for specific categories of Passengers	100
22	Bringing animals into Public Transport or Public Transport Facilities and Services, except for guide dogs accompanying blind persons	100
23	Carrying or using materials or equipment that may cause a nuisance to users of Public Transport or Public Transport Facilities and Services or endanger their safety	400
24	Using any safety or security device, including emergency exits, except in cases of necessity	4,000
25	Sleeping in Passenger shelters or in any place where sleeping is prohibited	300
26	Engaging in any act or behaviour that distracts, or obstructs the view of, a Public Transport driver while driving	400
27	Standing or sitting in areas not designated for Passenger use on Public Transport or within Public Transport Facilities and Services	100
28	Placing feet on seats	100
29	Eating or drinking in areas where eating or drinking is prohibited	100
