

Executive Council Resolution No. (19) of 2010
Approving the
Fees and Fines Prescribed by the Traffic Toll Law of the Emirate of Dubai¹

We, Hamdan bin Mohammed bin Rashid Al Maktoum, Crown Prince of Dubai, Chairman of the Executive Council,

After perusal of:

Law No. (22) of 2006 Concerning the Traffic Toll in the Emirate of Dubai and its amendments;
and

Executive Council Resolution No. (17) of 2006 Approving the Fees and Fines Prescribed by the Traffic Toll Law of the Emirate of Dubai,

Do hereby issue this Resolution.

Article (1)

Vehicle Owners whose vehicles pass through Traffic Toll Gates in one direction will pay the fees prescribed in Schedule (1) attached hereto.

Article (2)

- a. A Vehicle Owner who commits any of the violations stipulated in Schedule (2) attached hereto will be punished by the fine indicated opposite that violation.
- b. Upon repetition of the same violation within one (1) year from the date of the previous violation, the amount of the fine referred to in item (1) of Schedule (2) attached hereto will be doubled no more than three (3) times a year.

Article (3)

The above-mentioned Executive Council Resolution No. (17) of 2006 is hereby repealed. Any provision in any other resolution will also be repealed to the extent that it contradicts the provisions of this Resolution.

Article (4)

This Resolution comes into force on the day on which it is issued, and will be published in the Official Gazette.

3	Tampering with the Traffic Toll Card or using it in a fraudulent manner	10,000.00
4	Damaging an Electronic Payment Machine or a Traffic Toll Gate	10,000.00
