

**Executive Council Resolution No. (20) of 2014**

**Appointing Members of the

**Article (1)**

  3. a representative from the Department of Economic Development, as member;

  5. a representative from Emaar Properties, as member;
  6. a representative from Majid Al Futtaim Group, as member;
  7. a representative from Al Tayer Group, as member;
  8. a representative from Dubai Textile City, as member;

10. Reem Aftim Acra, as member;
11. Ali Mustafa Jaber, as member;
12. Raji Patrick Chalhoub, as member;
13. Raja Fares Trad, as member;
14. Ghassan Samir Harfoush, as member;
15. Nisha Wadhmal Jagtiani, as member; and
16. Azza Abdul Men'em Fahmi, as member.

The term of the Council will be three (3) years, renewable upon expiry.

- b. The representatives of the entities referred to in paragraph (a) of this Article will be nominated by the officials in charge of these entities.
- c. Where the term of membership of the Council members mentioned in paragraph (a) of this Article is not renewed upon expiry, the Council members will continue to perform their duties until their membership is renewed or they are replaced by new members.

#### **Article (2)**

This Resolution comes into force on the day on which it is issued, and will be published in the Official Gazette.
