Administrative Resolution No. (100) of 2020 Concerning the Cancellation and Reduction of Charges for Services Provided by the Dubai Health Authority

**Cancellation and Reduction of Charges**  
**Article (1)**

Pursuant to this Resolution, the charges for certain services provided by the DHA are cancelled or reduced, as stated in Schedules (1) and (2) attached hereto.

**Implementation**  
**Article (2)**

All organisational units of the DHA, each within its own powers, must take the necessary action to implement this Resolution.

**Repeals**  
**Article (3)**

Any provision in any other administrative resolution will be repealed to the extent that it contradicts the provisions of this Resolution.

**Commencement and Publication**  
**Article (4)**

This Resolution comes into force on 1 March 2020, and will be published in the Official Gazette.
