We, Mohammed bin Rashid Al Maktoum, Ruler of Dubai,

After perusal of:

Do hereby issue this Decree.

Formation of the Board of Trustees

The term of the Board of Trustees will be three (3) years, renewable upon expiry.

- b. Where the Board of Trustees is not reconstituted upon expiry of the term of membership of the Board of Trustee members mentioned in paragraph (a) of this Article, these members will continue to perform their duties until they are re-appointed or replaced by new members.

This Decree comes into force on the day on which it is issued, and will be published in the Official Gazette.
